THEREFORE, _____, (print full name) applying to hunt, for the year stated above, and wishing to hunt deer, and/or other legal game, does the following:

1. Acknowledges that hunting is a very dangerous sport and that, in our litigious society, Owners or Lessees could potentially be exposed to a lawsuit or lawsuits should hunter injure himself/herself or others.
2. Waives his/her rights to take legal action against the Owners, Lessees and their agents or employees for any and all injuries or damages he/she may suffer for any reason while on the Farms, including but not limited to injuries or damages suffered while hunting.
3. Releases the Owners, Lessees and their agents or employees from any and all liability with respect to all injuries or damages he/she may suffer for any reason while on the Farms, including but not limited to injuries or damages suffered while hunting.
4. Indemnifies the Owners and Lessees to the full extent of his/her assets and liability insurance against any economic losses Owners or lessees may suffer or be caused to incur that result from his/her alleged or adjudicated wrongful acts against others.
5. Affirms his/her understanding of this Waiver, Release and Indemnification, or that he/she has consulted with an attorney for advice and an explanation of the terms of this Waiver, Release and Indemnification, and that the force of this Waiver, Release and Indemnification shall survive the 2012 – 2013 hunting season term of this Waiver, Release and Indemnification; and
6. Affirms his/her understanding of this Waiver, Release and Indemnification by signing his/her name below.
7. Understands the amount of available property to hunt may from time to time increase or decrease due to various factors beyond the control of the Owner and, Hunter agrees to check with the Owner immediately prior to any hunt to ensure any respective lease is in full force and affect for any and all properties.
8. Understands these fees and hunt costs are voluntary and NON REFUNDABLE with deposits due at booking and balance due 30 days prior to hunt.
9. Agrees to follow all rules as presented in writing at any time during the hunting season and these rules always include Scent Elimination Clothing, and Antler Restrictions of not less than 140” for Farms 1 & 2 and not less than 125” for Farms 3, 4&5 (or as amended) as defined below for item 11.
10. Agrees to allow the owner, at his own expense, to have a replica made of any deer killed while hunting on property under his control.
11. Hunters, by signing below, agree that, subject only to the discretion of MWSP, LLC, a deer not meeting the minimum score agrees to payment of a fine of \$100.00 USD per inch of deficient antler length (Pope & Young Standards for Bow; and Boone and Crocket Standards for Gun) payable immediately to Mid West Sporting Properties, LLC.
12. Bag Limits are established by the Owner. Unless otherwise noted, they include one Antlered Deer per hunter. Bag limits are sometimes expanded at the discretion of the owner to include additional animals.
